7. Future Goals:

- Hiking Guide. These are selling like hotcakes. Ed suggested that if we could have an LNS member receive on-line orders or orders by phone and mail out the books we would do more business. Jeff volunteered that when he returns to Lillooet full-time (mid-May) he would be willing to take phone orders. Naturally, we hope that a 2nd edition of the Hiking Guide will be necessary.

- At the next FBCN and Nature Canada meeting, Vivian will be bringing forth resolutions re species at risk and habitat loss.

- Ore Creek Protection (Susan Brown addressed this). The status of the disputed area is uncertain at present. To be discussed in future (next regular meeting?) with Bill Spence.
- Blue Bird boxes: discussion of funding for new boxes will be brought forward at the next regular meeting. LNS notes with sadness the death of Harry Purney who did so much work to maintain the nestbox trail. Chris Galleazzo has taken over this work and will be arranging a work party for later in the spring. A member has suggested naming our bluebird trail after Harry Purney.
- Botanist Bill Merilees is still planning a summer (June) visit. He will be willing to lead a botany field trip at that time.
- Bridge Coastal Restoration Program: Vivian and Larry Casper attended the BCRP meetings in January and supported study applications on owls, riverine birds, and various tree species and projects.
- Glenda offered to co-ordinate some form of LNS activity or project for April Earth Day.
- Susan suggested a trip to Botanie Valley for wildflowers. Obtaining band permission may be an issue. Bill Merilees would like to visit this area as well. Further discussion at next regular meeting.
